Implementing the New CGSB72.34-2016 National Standard into Your RIM Program

Presented jointly by: Uta Fox, CRM, Manager Records and Information, Calgary Police Service; and Stuart Rennie, Lawyer and Records Management Consultant

The Canadian General Standards Board recently posted an updated draft of CAN/CGSB72.34 Electronic Records as Documentary Evidence and is currently working to update the CGSB72.34-2005 standard. The new version will provide for the principles for the creation and management of all forms of electronic records to support their admissibility as evidence in legal proceedings. This presentation will review and discuss the changes from CGSB72.34-2005 to the latest draft version of CGSB72.34 from the legal perspective. It will also discuss how to implement CGSB 72.34 into an organization's Records and Information Management program from the policy and procedure perspective to ensure the organization addresses that its electronic records meet admissibility requirements in court proceedings.

Speaker: Uta Fox, CRM, Manager Records and Information at the Calgary Police Service

Uta Fox is the Manager, Records & Information, Records and Information Management Section, Calgary Police Service. She holds a Master's Degree from the University of Calgary and is a Certified Records Manager. Coauthoring several ARMA International publications, Uta is a member of its Content Editorial Board and is ARMA Canada's Director of Canadian Content.

Guidelines for Bursaries Awarded to ARMA Calgary Chapter Members

Conditions of Award

Twice yearly, the ARMA Calgary Chapter will be offering two \$500.00 bursaries intended for use by its recipients to pursue education/training in the field of records and information management. These bursaries are awarded to members in good standing.

Each Fall - a \$500.00 bursary is to be awarded (Application deadline October 14th) Each Winter – a \$500.00 bursary is to be awarded (Application deadline December 31)

The bursaries will be based on the financial need of the applicant.

Applications and all supporting documentation must be filed with the ARMA Calgary Chapter by October 14th to be eligible for Fall bursary and December 31st to be eligible for Winter bursary in each year.

Guidelines and applications are available on the ARMA Calgary Chapter web site (www.armacalgary.org). The bursary will be tenable for a program of study leading to learning in the field of records and information management and will not be awarded to the chosen recipient until evidence is provided for the registration and completion by the candidate's attendance and course completion.

Bursaries will only be awarded once to any individual in a 21 month period.

Authentic signature of the actual applicant must appear on Application Form. Any other signature will cause the application to be invalid and therefore denied.

Eligibility

The Applicant must be an ARMA Calgary Chapter member in good standing at the time of the application. A member in good standing is defined as a duly qualified individual with ARMA International and is a registered member of the ARMA Calgary Chapter.

Requirements

- 1. All questions (blank spaces) on the application form must be completed. The application form must be signed by the applicant.
- 2. 'Letter of Registration' for a program, course, seminar, etc in the field of records and information management must be included. A confirmation of registration is also required at the time of the application or within 60 days of receipt of the bursary award.
- Financial support of applicant's organization of employment must be declared on the application form (if any).
- 4. Those receiving a bursary must be prepared to enter into normal publicity that goes with receiving such an award (newsletter announcement, social media, as well as announcement in an ARMA International publication).
- 5. The ARMA Calgary Chapter bursaries are available only to ARMA Calgary Chapter members.
- 6. Current ARMA Calgary Board members are not eligible to receive a bursary during their tenure on the board.

The President, President-Elect, Past President and Education Director of the ARMA Calgary Chapter will review and administer the awards by evaluating all requests.

All information obtained on the application form will remain confidential within the above evaluation committee and destroyed at one year after the application deadline.
